<p>1. Eligibility and Technical Requirements</p> <p>a. PhilGeps Certificate of Registration-Platinum Membership</p> <p>b. Statement of the Largest Single Completed Contract (SLCC)</p> <p>c. Statement of ongoing government and private contracts, including private contracts awarded but not yet started</p>	<p>➤ Only the PhilGeps Registration shall be required, the Platinum Membership shall be waived; but in lieu of the Platinum Membership the following shall be submitted by the prospective bidders;</p> <p>a. Department of Trade and Industry (DTI) business name registration for sole proprietorship or SEC Registration Certificate, or Cooperative Development Authority (CDA) for cooperatives;</p> <p>b. Valid and current Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located;</p> <p>c. Tax Clearance per Executive Order 398, Series of 2005 (finally reviewed and approved by the BIR)</p> <p>➤ The SLCC shall not be required;</p> <p>➤ The required Statement of on-going government and private contracts shall be revised (<i>see attached form</i>);</p> <p>➤ Revisions are as follows:</p> <p>a. Bidders are required to declare at least five (5) on-going biggest contracts in terms of amount;</p>

<p>2. Deadline of Submission and Opening of Bids</p>	<p>b. For Open-ended Contracts, the basis of Contract Amount shall be the total transaction amount for the period June 2017 up to May 2018;</p> <p>c. The value of outstanding contract shall be the estimated transacted amount for the next 12 months(June 2018- May 2019)</p> <p>d. Copy of the MOA/Contract/ Credit Line Agreement or similar document shall be required for the five (5) declared on-going contracts.</p> <p>➤ The deadline for the submission and opening of bids shall be on June 28, 2018 (Thursday) 10:00 am at the GSD Conference Room, National Transmission Corporation, BIR Road corner Quezon Avenue, Diliman Quezon City.</p>
