On 23 May 2017, President Rodrigo R. Duterte issued Proclamation No. 216, placing the entire Mindanao Group of Islands under Martial Law effective within the next sixty (60) days. The same was precipitated by the on-going conflict between the Maute Group and government forces in Marawi City, Lanao Del Sur.

Considering the foregoing and the attendant security concerns in the area that will pose as a challenge to the mobility of stakeholders therein, prudence dictates the **CANCELLATION** of the **EXPOSITORY PRESENTATION** scheduled on **2 June 2017 in DAVAO CITY** and the **PRE-TRIAL CONFERENCE and EVIDENTIARY HEARING** scheduled on **9 June 2017 in ERC Head Office, Pasig City**.

All interested parties to the instant case are advised to await further notice from the Commission for the re-scheduling of the said public hearings.
